

6 QUESTIONS ABOUT THE DEATH PENALTY



DOES THE DEATH PENALTY DETER CRIME? NO EVIDENCE.

A review of deterrence studies over several decades by the National Academy of Sciences found no credible evidence that the death penalty impacts murder rates one way or the other.

MURDER RATES ARE 25% LOWER IN NON-DEATH PENALTY STATES



FBI data from the past decade show that states without the death penalty have lower overall murder rates than those with it. As of 2015, the gap was 25%.

DOES OUR CRIMINAL JUSTICE SYSTEM CONVICT INNOCENT PEOPLE? YES. MISTAKES HAPPEN.

It has taken on average over 11 years for those wrongfully sentenced to death in the U.S. to prove their innocence – and in some cases over 30 years. A review of exonerations based on DNA evidence (in both death and non-death penalty cases) shows that the most common causes of wrongful convictions are:

73% EYE WITNESS MISIDENTIFICATION

23% FALSE CONFESSIONS

16% INFORMANTS/"SNITCHES"

52% UNVALIDATED/IMPROPER FORENSICS



IS THE DEATH PENALTY SYSTEM FAIR? NO, IT'S ARBITRARY.

Similar crimes are prosecuted very differently due to arbitrary factors:

- geography; similar crimes are prosecuted differently depending upon the people, resources and political climate of the district
- economic factors; whether defendants can afford their own attorneys
- experience level of defense counsel
- race of victim

Despite efforts to make the death penalty humane with lethal injections, botched executions have been a persistent problem with this method of execution. In recent years, executions have involved inmates gasping, choking, and struggling before finally dying, long after the lethal dose was intended to take effect. The secrecy of drug sources, as well as prison staff without advanced medical training administering the drugs, results in a process prone to error.
